On a motion of Councilor Alexander, seconded by Councilor Dove and with unanimous (4-0) affirmation of the Town Board, the Board approved the Rotary's request to use the Austin Pavilion for the annual Father's Day Pancake Breakfast June 12, 2024, through June 17, 2024, and to waive the fee for the event.

Water Department GIS Mapping System: Shane Christman, Skaneateles Water Department Foremen reviewed the following quotes the Water Department had received for the GIS Mapping System:

Mr. Christman reviewed the two different systems. The Trimble system's higher cost is based on the fact it would need an additional software program to run. The Eastcom system is a cloud based program with open sourced software.

He stated he had tested the Eastcom system with the sample data and it worked well. The system would create a GIS mapping system for the Town water infrastructure. He recommended the Eastcom system.

Town Engineer Robinson agreed with Mr. Christman. She stated the Eastcom system would work well. This system would need software, but the software is open-sourced and there is no charge.

On a motion of Councilor Alexander, seconded by Councilor Dove, and with unanimous (4-0) affirmation of the Town Board, the Skaneateles Water Department was authorized to purchase the Eastcom GIS Mapping System at a cost not to exceed \$4000.

Skaneateles Library Letter of Support and Resolution for Grant Application: Supervisor Legg announced the Skaneateles Library was seeking grant funding for their new facility on Fennell Street and had requested a letter of support from the Town of Skaneateles.

On a motion of Councilor Dove, seconded by Councilor Milne and with unanimous (4-0) affirmation of the Town Board, the Resolution in support of the new Library facility was accepted as presented.

M&T Bank New Third Part Custodial Agreement with Wilmington Trust: Supervisor Legg stated the Board was in receipt of a request from M&T Bank to authorize the change of the bank's third part custodial agreement to Wilmington Bank.

Budget Officer Fey explained to the Board that the Town of Skaneateles uses M&T Bank as one of their official depositories and M&T Bank is asking to move the funds to Wilmington Bank as their third-party financial backing.

Councilor Alexander stated that the agreement stated that there would be a personal meeting with the bank. They had talked about scheduling a meeting with the representatives from M&T bank and she would like the Board to have this meeting before authorizing this agreement.

The Board agreed and tabled the authorization until they could meet with representatives from M&T Bank.

NY American Water Works Association (AWEA) annual meeting April 9th -11th – Supervisor Legg stated Town Engineer Robinson and Water Foreman Christman were requesting authorization to attend the NY American Water Works Association annual meeting April 9, 2024 -April 11, 2024.

On a motion of Councilor Milne, seconded by Councilor Alexander and with unanimous (4-0) affirmation of the Town Board, Town Engineer Robinson, and Water Foremen Christman were approved to attend the AWEA annual meeting from April 9, 2024 – April 11, 2024.

Deckard Technologies Rentalscape - Occupancy Tax Proposal: Councilor Alexander reported she had spoken to Deckard Technologies at the Association of Towns Conference. This is a company that locates short-term rentals. This is a service that would locate the short-term rentals and Airbnb's for the Town to be able to collect the Occupancy Tax recently enacted in the Town of Skaneateles.

This company provides a program that maps out anyone who has a short-term rental online. It also shows how many days the property was rented for over the year and their revenue. It is an amazing program.

Councilor Alexander stated they have various levels of service. The level she would like the Board to consider is a lower cost level that would help the Clerk's office locate and track these properties. The program gives locations, addresses, owners, and revenue. The Town could contract for a year to get a handle on the properties in the Town of Skaneateles. She stated when she did a quick search on the Deckard Technologies program, she found online rental properties in the Town had done 1.7 million dollars in revenue in the past year.

Councilor Alexander stated the cost for one year for the lower service level would be around \$3,000. She would like to schedule a presentation from Deckard Technologies and get some pricing for the Board to consider.

The Board discussed the program and what it could offer the Town and agreed to have Councilor Alexander schedule a presentation from Deckard Technologies for a future Board meeting.

Schedule Special Town Board Meeting April 9, 2024, at 5:00 p.m. — Supervisor Legg stated the Board needed to schedule a special meeting to continue contract negotiations.

On a motion of Councilor Dove, seconded by Councilor Alexander and with unanimous (4-0) affirmation of the Town Board, scheduled a Town Board Special Meeting for executive session for contract negotiations.
