#### Resolution #18-184

Amendment for Agreement for the Expenditures of Highway Moneys: Highway Superintendent, Allan Wellington explained, he submits an agreement for the expenditure of highway moneys every year. He is asking for an amendment to the agreement this year to amended as follows: to add West Elizabeth Street, a distance of .09 miles, not to expend over the sum of \$20,074.59.
