RESOLUTION ORDERING DEMOLITION AND REMOVAL OF THE PROPERTY LOCATED AT 1819 CHERRY VALLEY TURNPIKE, TAX MAP NUMBER 034.-01-06.1, PURSUANT TO CHAPTER 42 OF THE SKANEATELES TOWN CODE.

WHEREAS, the Code Enforcement Officer of the Town of Skaneateles (the "Officer"), submitted a report (the "Report") relating to the property located at 1819 Cherry Valley Turnpike, Tax Map Number 034.-01-06.1 in the Town of Skaneateles (the "Building");

WHEREAS, the Officer presented facts and evidence to support his opinion and Report that the Building is unsafe and dangerous as defined in Chapter 42 of the Skaneateles Town Code;

WHEREAS, the Officer is of the opinion that the Building is beyond the state of repair such that it cannot be safely repaired for securing and therefore should be demolished and removed;

WHEREAS, after considering the Report submitted and made by the Officer, the Town Board is of the opinion that the Building is unsafe and dangerous;

WHEREAS, that in order to provide for the safety, health protection and general welfare of the persons and property in the Town, the Town Board is of the opinion and the Report so warrants, that the Building cannot be safely repaired for securing and therefore is of the opinion that the Building must be demolished and removed;

NOW, THEREFORE, BE IT RESOLVED, that pursuant Chapter 42 of the Skaneateles Town Code, the Town Board is of the opinion, and the Report so warrants, that the Building located at 1819 Cherry Valley Turnpike in the Town of Skaneateles, County of Onondaga and State of New York, further identified by Tax Map Number 034.-01-06.1 is unsafe and dangerous and cannot be safely repaired for securing; and be it further

RESOLVED, that the Building is hereby ordered to be demolished and removed pursuant to and in accordance with Chapter 42 of the Skaneateles Town Code; and be it further

RESOLVED, that the Town Supervisor is hereby authorized and directed to prepare and serve the necessary notices in accordance with Chapter 42 of the Skaneateles Town Code, and upon completion such service thereof to file the same in the office of the County Clerk of the County of Onondaga; and be it further

RESOLVED, that the Town Board will hold a public hearing to hear all persons interested in demolition and removal of the Building, which public hearing shall be held August 7, 201 at 7:30 p.m. and be it further

RESOLVED AND ORDERED that the Town Clerk shall give notice of such hearing by publishing a copy of this resolution in the official Town newspaper, and by posting a certified copy of this resolution on the Town's official sign-board, not less than ten nor more than twenty days before such hearing.
