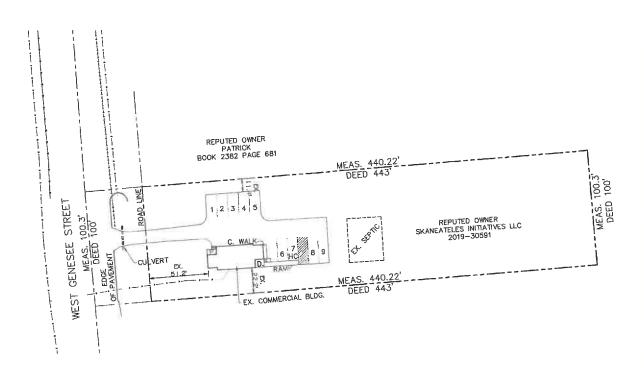

NARRATIVE

The property at 796 West Genesee Street is 39,189 SF, has 100.0 ft of road frontage on West Genesee Street (US Rte 20) in the HC District and the Skaneateles Lake Watershed. The property has an 859 SF single floor commercial building and a gravel parking area. The site is flat and at the west edge of the Highway Commercial District. The site is served by Town water and has an existing septic system. The ISC is 8.6% and TSC is 8.8% whereas 33.3% ISC and 40% TSC is allowed. Since the survey was done, the parking area was paved more like earlier parking areas and the ISC is 15.2% and TSC is 15.4%

This application is to change the use of the building from a glass service business to a Dog Grooming service business. There will be no change in the structure or site. Nine parking spaces including a handicap designated space adjacent to the ramp on the south side of the building are available on site. The business will have a 12 SF free standing sign and signage on the front of the building.

The Dog Grooming business will have one to two employees and be open Monday through Friday 7:30am to 6:00 pm, Saturday 7:30 through 4:00 pm. They will groom 5 to 8 dogs per day with them being held in a crated holding area and exercised on leash in the back yard as required. The business will also offer pickup and drop off service using a company vehicle. Off site, the business will offer dog walking, dog adventures and check in on pets at home. They will not do any dog boarding and no dogs will be left onsite overnight or without employees also on site. If the company vehicle is parked on site overnight, it will be behind the building.
