

Animal Control

Let me tell you I have been doing this animal control stuff for the town for over twenty years and I still don't have half of the insight that many callers have. I called and surprise surprise it was the previous days caller. I wonder if she thought they moved the town line. Then it got real tricky. She had her husband call. I wonder if they thought they could fool me.

How about the call from the young gentleman who wanted to know how to get a license for a couple of baby foxes. He told me that he was going to adopt a couple of red foxes from a breeder. I told him that they are wildlife and that I didn't think he was allowed to possess them. He responded, "so there is no town permit?" To which I told him "no not that I'm aware of" but, that he

really needed to contact The NY Department of Conservation for clarification. We know babies are Baby raccoons are cute. cute, kittens, puppies, little duckies they are all cute. Taverns of Skaneateles

Taverns in the early days were an important part of a community. Weary travelers looked to them as a place where they could receive a meal and as place to rest their tired heads. Farmers and townspeople alike would gather at the nearby tavern and, over a glass of ale, learn of the news outside the community or discuss farming, business, politics or religion. Or maybe they would just relax while playing a game of checkers. The harshness of life in those days could be softened by a drink at the tavern

A glowing fire in the fireplace made the tavern especially inviting in the winter time. And tavern keepers were expected to keep a good supply of grease or tar on hand, along with a large jack which would allow patrons to raise their wagons and grease the wheels.

There were many taverns in Skaneateles, the first in 1795. A militia captain by the name of Welsh built a log tavern approximately where the Savings Bank stands today, at the corner of East Genesee Street and State Street. Several years later he added a two-story frame addition to the west side. Still later another addition was built to accommodate the travelers horses.

In 1806 John Briggs built a tavern near the lake shore at the corner of West Genesee Street and West Lake Street. It later was turned into a home, and eventually was torn down to make room Shotwell Memorial Park.

In 1807 Isaac Sherwood built the original tavern where the Sherwood Inn stands today. This was the headquarters for his stage coach business. The original building was torn down and replaced by the building which has changed over the years into the Inn we know today.

In the early days of Skaneateles, the making and selling of whiskey was considered to be an honest undertaking. It was thought to be out of character for a person to get drunk. Every respectable man kept some on hand for friends when they called for a business or social visit. Winston Day was the first distiller of liquor in this area. Others such as Hezekiah Earll in Hart Lot, Colonel Daniel Earll and son, Abijah, in Willow Glen.

At one time Deacon David Hall operated a distillery on the east side of the inlet at the head of the lake. His barrels of whiskey and wines came down the lake to the village by schooner.

The schooner would stop at Appletree Point or Carpenter's Point, where casks of whiskey were added to the shipment. This whiskey came from John Carpenter's distillery which he operated at the brink of Carpenter's Falls from 1825 to about 1875, in the town of New Hope. The barrels of whiskey were carried down to the dock by way of "Jug Path." (People would climb that very same hill, carrying their jugs in anticipation of filling them at the distillery, thus the name.)

The Earll brothers, Julius and George profited greatly when in 1860-61 Congress decided to place a tax of \$2 on every gallon of distilled spirits manufactured after the first day of July. They ran their distillery day and night without Stopping. By the last day of June they had accumulated a large supply of whiskey. Then they shut the distillery down.



On July I, with the newly imposed tax, the price of whiskey rose by two dollars. But as the Earll brother's whiskey had been produced prior to the deadline, there was no tax on their product. Thus they collected \$2 on every gallon of whiskey they sold, netting the brothers thousands of dollars.



From the Assessor's Office

BASIC STAR PROGRAM: As you all have heard those receiving the Basic STAR in 2013 will need to apply directly with the New York State Department of Taxation in order to receive this exemption for 2014. REMEMBER this only applies to those receiving the Basic STAR and not those who received the Enhanced STAR in 2013.

The following is what I know at this time:

- They will be mailing out the Basic STAR reregistration forms sometime in September/October. There will be a unique STAR identifier on these forms.
- The form will instruct you to go on-line where you will have to answer a few short questions. In addition, there will be a phone number to call for those without internet access. NO paper applications will be accepted.
- There will be 2 reminder letters to those who have not applied by certain dates and within 45 days of notifying the Assessor's office to remove the exemption, they will send a removal letter to the property owner.
- The Assessor's office will receive a list of those who did not apply sometime in February and will remove those from the 2014 assessment roll.
- Should the State deny the exemption there is nothing the Assessor or Board of Assessment can do to grant it. The property owner must deal with the State.

There are still a great number of issues outstanding and as I find out more I will attempt to keep everyone informed by the Town newsletter or in the Skaneateles Press and Journal. In addition, the following new penalties, sanctions and fees have been enacted:

- Penalties for intentionally providing misinformation to an assessor will increase from \$100 to as much as \$2,500.
- The number of years for which a taxpayer must repay inappropriate STAR benefits will increase from three to as many as six years
- Taxpayers whose STAR exemption is revoked will be unable to receive the exemption for six years after the revocation
- An additional \$500 processing fee will be imposed whenever an inappropriate exemption granted after April 1, 2013 is revoked.

ENHANCED STAR PROGRAM

This program will continue as it has in the past. This office will mail Enhanced STAR exemption renewal forms out once the State has revised the forms for 2014. It is anticipated this will be sometime in mid-September or early October. One change in 2014 will be the maximum income limit will be increase from \$79,050 to \$81,900.

issued Nuisance Wildlife Control Operator license. This license sets the rules on what kind of animals we can deal with. It allows us to trap and remove some animals and prohibits the handling of others. It allows us to remove a nuicanse anmal if it "destroys property or poses a threat to public health". Example a raccoon is tearing into your garbage destroying the bag. We could trap and remove the raccoon. Of course I would recommend that you put your trash in a trash can, but who am I. Now the snapping turtle is one of the species that we are prohibited from handling. If it is a matter of public safety the

police should be notified. The police were on the scene and I advised them to keep people away. A snapping turtle is not an aggressive animal. I have never heard of one chasing a jogger or taking down a bicyclist. Perhaps the one at the school was a teenage mutant ninja turtle.

Lets enjoy wildlife. Be safe and keep your distance.

Please don't steal someones dog because you think it looks lost.

Finally thank you for the calls. Without them I wouldn't have anything to write about in the newsletter. I guess I wouldn't have a job either.

Laker Limo "always" needs more Volunteers

The Laker Transportation Project is a non-profit transportation provider for senior and disabled residents of Skaneateles. Familiarly it is known in the community as "Laker Limo". Requiring only that reservations be made two days in advance, Laker Limo provides daily door-to-door transportation weekdays from 9:00-5:00. To make a reservation for transportation, simply call the reservation voicemail system 685-3030. The reservation request must include name, address, phone no., destination address, and appointment time.

The project is made possible by a team of approximately 70 trained volunteers that rotate their donated time monthly to man either a 10-seat shuttle bus with two wheelchair lockdown stations or a 6-seat mini van. Volunteers donate one day a month. A schedule is made up quarterly, so volunteers know well in advance theirs days of service. With both a driver and escort on board during all trips, riders can be comfortable during transportation with conversation and, if necessary, can be physically assisted during arrival and departure. Volunteers are always needed. Anyone interested in lending a helping hand should call Laker Limo voicemail, 685-3030, and a representative will respond.

Our community continues to amaze us with the wonderful generosity shown in support of the Postal Workers' Food Drive in May. This year the support was even larger than in the past. The seven Morning Rotary members worked three hours shelving all that was received. Thank you to our mail carriers who transported all of it to us.

The Pantry's fiscal year ended as of June 30th. We served 34,895 meals to 4,369 individuals. These figures have stayed pretty much the same as last year. We did purchase 12,000 pounds of food from the Food Bank of Central New York. Through the Food Bank we enjoy a 185% rate of return on each dollar spent.
