Abstract #25-22: On a motion of Councilor Milne, seconded by Councilor Lotkowitz, and with unanimous (3-0) affirmation of the Town Board vouchers were authorized from the following funds:

Lease Agreements – Limeledge Water District and Route 20: Supervisor Legg stated the Town Board was in receipt of the updated lease agreements with Craig Richard for Town property on Route 20 and the Ken Richards for Town property in the Limeledge Water District. These are leases to farm these two Town owned properties.

The lease agreements were in the amount of \$75 per acre, Attorney Smith confirmed \$75 was a fair market price based on Councilor Mark Tucker's research.

On a motion of Councilor Milne, seconded by Councilor Lotkowitz, and with unanimous (3-0) affirmation of the Town Board, the Town Board authorized Supervisor Legg to sign the lease agreement with Craig Richards to farm Town property on Route 20 in the Town of Skaneateles for a cost of \$75 per acre for a term of 7 years, expiring December 31, 2032.

On a motion of Councilor Milne, seconded by Councilor Lotkowitz, and with unanimous (3-0) affirmation of the Town Board, the Town Board authorized Supervisor Legg to sign the lease agreement with Ken Richards to farm Town property in the Limeledge Water District in the Town of Skaneateles for a cost of \$75 per acre for a term of 7 years, expiring December 31, 2032.

Board of Assessment Review Appointment: Supervisor Legg stated Councilor Milne and Councilor Dove had interviewed candidates for the open position on the Board of Assessment Review and recommend the Board reappoint Mike Zuber.

On a motion of Councilor Milne, seconded by Councilor Lotkowitz, and with unanimous (3-0) affirmation of the Town Board, the Town Board appoint Mike Zuper to the Town of Skaneateles Board of Assessment Review for the term of January 1, 2026 – September 30, 2030.

Planning Board Appointment: Supervisor Legg stated Councilor Tucker, Councilor Lotkowitz and Planning Board Chair Don Kasper interviewed candidates for the open position on the Planning Board and recommended the Board appoint Steve Ladd to the term expiring December 31, 2028 Rick Keys to the term beginning January 1, 2026 and expiring December 31, 2030.

On a motion of Councilor Lotkowitz, seconded by Councilor Milne, and with unanimous (3-0) affirmation of the Town Board, the Town Board appoint Steve Ladd to the term expiring December 31, 2028.

On a motion of Councilor Milne, seconded by Councilor Lotkowitz, and with unanimous (3-0) affirmation of the Town Board, the Town Board appointed Rick Keys to the Planning Board for the term beginning January 1, 2026 expiring December 31, 2030.

Zoning Board of Appeals Appointment: Supervisor Legg stated Councilor Tucker, Councilor Lotkowitz and Zoning Board chair interviewed candidates for the open position on the Zoning Board of Appeals and recommended the Board reappoint Jim Condon with a term of January 1, 2026 to December 31, 2030 and to appoint Beth Estes to the Dave Palen's term, which expires in December 2028. Dave would amend his resignation to February 28, 2026 and Beth Estes would begin on the Zoning Board of Appeals March 1, 2026.

On a motion of Councilor Milne, seconded by Councilor Lotkowitz, and with unanimous (3-0) affirmation of the Town Board, the Town Board appointed Jim Condon to the Zoning Board of Appeals for the term beginning January 1, 2026 expiring December 31, 2030.

On a motion of Councilor Lotkowitz, seconded by Councilor Milne, and with unanimous (3-0) affirmation of the Town Board, the Town Board accepted Zoning Board member Dave Palen's amended resignation letter stating his resignation date would be February 28, 2026.

On a motion of Councilor Milne, seconded by Councilor Lotkowitz, and with unanimous (3-0) affirmation of the Town Board, the Town Board appointed Beth Estes to fill Dave Palen's term ending December 31, 2028 starting March 1, 2026.


